**Newton Municipal Pool
Use of Facilities Regulations**

Availability of Facilities

1. NRC functions shall have first priority in the use of the facilities. Rental Requests will be taken starting Jan 31 of 2010. Dates of use will not be confirmed prior to April 1st of 2010. The Aquatics Director may approve earlier confirmation if special circumstances exist.
2. The Municipal Pool will not be available for any group on the following days:
Memorial Day
4th of July
Labor Day
Newton Community Festival Days
3. The Newton Recreation Commission may, at any time, refuse to open or grant access to the pool.
4. The use of the pool must be confined to that stated in the written request.

Prohibited Activities

5. Use of tobacco products, use of alcoholic beverages, concealed weapons, and disorderly conduct is prohibited.
6. No animals are allowed in the Municipal Pool facility.

Payment and Cancellations

7. All charges must be paid **upon making the reservation.** If more attend than planned, the party must make up the payment at the end of the reserved time. If less, no refunds will be given.
8. Cancellation Procedures:
If the individual cancels 2 weeks or more before the scheduled date, 75% is refunded.
If the individual cancels within 2 weeks of the scheduled date, 50% is refunded.
If NRC cancels the date, 100% is refunded if unable to reschedule.
In the case of inclement weather, 100% is refunded if unable to reschedule.
In the case of unfavorable water conditions, 100% is refunded if unable to reschedule.

Other

9. The person, persons, or group making application for this facility shall reimburse NRC for any damages to the facility or equipment by persons in the group.
10. Organizations using the Municipal Pool must be supervised by adequate number of adult sponsors to assure proper care and use of the facility.
11. Lifeguards and concession staff will be scheduled by the Municipal Pool Managers depending on the number of facility users.
12. Facility users must obey all Pool Rules as well as any guidelines given by pool staff.
